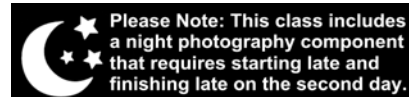


# Advanced Crime Scene & Evidence Photography For the Crime Scene Investigator

This is a three day (24 hour) hands-on workshop designed for the incident scene investigator that will enhance their photography skills in difficult situations. It presents detailed instruction in advanced photographic principles and exposure to useful photographic accessories

Persons interested in attending should have already completed a basic photography program and will be required to bring photography equipment including a tripod and off-camera flash.

The registration fee includes all materials used in the class including film and photo processing.

The small class size of this workshop is meant to allow students ample time to work through practical exercises and to permit the instructors to closely evaluate each student's work.
